Minutes

- 1. Call to order President Stewart called the meeting to order at 12:02 p.m.
- 2. Introduction Conducted.
- 3. Reading and approval of January meeting, February 5 and 9, and April special meeting minutes The minutes were provided in advance of the meeting for review.
 - A motion was made by Cuddeback, seconded by Stoddard to approve the January meeting, February 5 and 9, and April special meeting minutes. Carried.
- **4. Treasurer's report** Kemmeren shared her report. She stated that the NYS Envirothon was recently held so the Envirothon section is not accurate. Stewart asked what the -\$25 amount under Training Sessions Expenses Other was. Kemmeren stated it was a payment

to the City of Syracuse for the Water Quality Symposium training a few years back when it was held on Zoom. It was classed as a service in which Kemmeren needs to go in and move it. White noted that the Silent Auction amount was low. Kemmeren replied she put the money in the Water Quality Symposium line and would fix it. Burke asked why gun raffle income was only \$600 but the expense was \$1252.37. Kemmeren stated the \$600 was received from Katie WhitKovits and the rest of the money went into the wrong category in the Water Quality Symposium and she would fix it.

• The treasurer's report was tabled until the next meeting.

5. Partnership Reports

- a. New York State Soil and Water Conservation Committee Bzduch shared her report, appended to the minutes. Cuddeback commented that for CRF 8, Cayuga County and a few other counties put in a request for a 30-day extension to the deadline for proposals as it only gives Districts two months instead of three to get grant proposals written and submitted. He wondered if this was possible to extend the deadline. Halloran agreed with Cuddeback and added especially with all the changes to the program. Bzduch replied they are sticking with the original deadline, but she will take concerns to Greg Albrecht and Jennifer Clifford. Halloran had a question on the equipment purchasing guidance with farmers purchasing equipment and if Districts were worried about the liability. Bzduch stated that Best Management Practices that get implemented with cost-share funding need to follow the Operations and Maintenance requirement for that practice for the lifespan of that practice. She stated the issue is that most practices have a lifespan of 10 years and Districts are concerned that it is not practical for some equipment to be maintained for that time period. They are concerned about enforcement if the equipment has not been maintained or even on the property, but Bzduch stated changes have been made in the Operation and Maintenance guidance to help with these concerns. Regarding the Soil Health Certification, Ferry asked Division Representatives to reach out to their Districts to see if any would benefit from amendments to the soil health requirement policy requiring someone to be a Certified Crop Advisor. Cuddeback stated in Cayuga County they have the CCA certification and cross county lines to certify. He suggested checking around nearby counties to see if anyone has the certification.
- b. **NYACD** Hurlbutt shared her report, appended to the minutes. She added Dustin Lewis, and she has been working on a Cover Crop Grant for the last 3 years. The contract finally came through from the Iowa Soybean Association with Dustin Lewis being the lead and she will sign the contract.
- c. NRCS no report.

6. Division Reports

- a. **Division I** Campbell shared her report, appended to the minutes.
- b. **Division II** Cuddeback shared his report, appended to the minutes. CDEA Golf Tournament will be held at Casolwood Golf Course in Canastota on August 1st

- with a hard deadline for registration on July 22nd. Contact Doug Kierst or Russ Smith with any questions.
- c. **Division III** Yaw submitted her report, appended to the minutes.
- d. **Division IV** Brinkley shared her report, appended to the minutes. She added that as of today, the CREP statewide training program put on by FSA, NRCS and the USC was wrapped up with over 120 folks total mainly Farm Service Agency employees. She added Tioga County made a comment there is a need for more training opportunities beyond Conservation Skills Workshop and Water Quality Symposium due to the influx of new District employees. Stewart asked that counties send her requests for training. Halloran asked if this issue came up before and we discussed it. Stewart stated that at this year's Water Quality Symposium they offered the new improved New Employee Orientation Class but was not technical. Cuddeback stated he saw this at the Water Quality Symposium and Conservation Skills Workshop where they had to draw back the presentations that were advanced for the number of new employees in attendance. Stewart asked DiGiacomo if Greg Albrecht posted AEM training on SharePoint. He stated yes and asked Brinkley if the topics were ag or nonag. She said both for her Division. DiGiacomo added that the State Committee is developing field-based training for new and seasoned employees and hopes to host one in Western NY in July. Stoddard suggested encouraging employees to contact neighboring counties, schedule site visits and learn from their peers.
- e. **Division V** Stoddard shared her report, appended to the minutes. A question she had was how to effectively use the USFW system to report bats and what are the proper protocols. Brinkley stated a USFW person gave an update on bats, and she could get their name for her. Stewart thanked Warren County for sharing with Hamilton County their protocol for their mini-grant program utilizing Part C money with her county. Hamilton County offers the Caring Through Conservation Mini Grant Program which is huge for municipalities trying to offset expenses and has made them look fantastic. Projects are \$1,000 to a cap of \$2,000 with a total of \$10,000 allocated for this program.
 - **Division VI** Klemczak shared his report, appended to the minutes. He administered a Capital Region PRISM Grant to treat Hemlock Woolly Adelgid (HWA). A biocontrol beetle was released last fall for HWA control.
- f. **Division VII** Ferry shared his report, appended to the minutes.
- g. **Division VIII** O. Cunningham shared her report, appended to the minutes. Nassau County is looking for a soil testing class/training as they do not know how to take a sample or where to get the material to test the soil. Stewart recommended reaching out to Division Representatives with questions of soil testing. O. Cunningham stated she reached out to Shino Tanikawa, and she knows Cornell is another source.

7. Executive Committee Board updates

a. **Member at Large** – Halloran stated she is working with Kemmeren and also has sent out 4-Hour letters and received two final reports.

- b. **Secretary** Nothing to report
- c. **President** Stewart reported she attended 3 SWCC, 3 NYACD meetings, and the Special Programs Advisory Committee (SPAC) meeting, upholding the 4-Way Partnership and ensuring lines of communication are open. She congratulated the NYS Envirothon committee on a fantastic event and enjoyed being an oral presentation judge and taking photos. She is organizing a media and drone class for Conservation Skills and will oversee hotel reservations. Other work included assisting the new Division Representatives with their positions on the CDEA board, answering inquiries from District staff, and assisting DEC's Division of Water Green Energy Management Section with collecting information about District employees who hold CPESC or Erosion and Sediment Control certification. Stewart will create a survey to collect the requested information. Bzduch commented that they have compiled a list of CPESC and Erosion and Sediment Control certification holders and the AEA's are working on updating it.

9. CDEA Standing Committee

a. State Fair Committee— White reported a meeting was just held and picked a theme Careers within the Districts with a timeline showing where Districts started and where we are. Hoping to display equipment used years ago. The committee will be looking for old photos to display as well. At the booth, the new banners will be displayed. The sign-up link has been sent out and have twenty-four volunteers signed up so far. She noted it is hard to fill the 3 to 8 shifts. White encourages people to look at the signup and volunteer. The schedule is on the CDEA website. Stewart encourages all Board Members to sign up to volunteer. It is an unwritten rule that board members volunteer. You get a free shirt and parking, your name goes into a \$50 drawing, and you interact with a lot of people. O. Cunningham questioned the \$100 invoice for the State Fair and if counties pay that. White stated some pay, and some do not. So far forty counties have paid. For a long time, the request has been \$100, and all the money goes toward expenses for the booth. Campbell stated this question was brought up at the Envirothon but if there could be a Performance Measure you need to participate in a CDEA Event. DiGiacomo stated it is possible, but they want to keep Performance Measures as simple as possible and it is for District Board Members not employees. Stewart suggested it be for any CDEA Committee which would include State Fair, WQS, Cons Skills, Envirothon, Erosion and Sediment Control

Program, etc. Halloran stated she is hesitant about that because it would make it a mandatory thing. Humphrey asked if the time for travel and personnel time to staff the State Booth be charged towards AEM Reimbursement or could SWCC pay for this. Stewart stated that if you volunteer for two shifts for the State Fair the State Fair Committee will reimburse the hotel accommodation. Halloran agreed it is harder for those countries that are farther away. White stated the committee cannot reimburse a county for volunteers. Stewart states that in her District if you work a shift at the fair that is your full day of work. Brinkley stated it is not volunteering since you get paid by your District for outreach and education, maybe clarify that to staff to get them to attend. DiGiacomo stated he will mention the issue of the lack of volunteers for CDEA events at his Manager's Meeting.

- b. NYS DEC Endorsed 4-Hour Erosion & Sediment Control Online Training White submitted her report, appended to the minutes. Halloran asked White if she had support for the glitches in the program. White stated that she must figure them out herself since she has outdated iSpring software suite that doesn't offer that level of technical support.
 - A motion was made by Stewart, seconded by Cuddeback to purchase the most recent version of iSpring for \$770. Carried.
- c. NYS Erosion and Sediment Control Certificate Program No report.
- d. Conservation Skills Workshop Eskildsen reported the Conservation Skills Workshop committee met on May 9th in Syracuse to develop a draft schedule for this year's workshop. The workshop will be held September 23 26 in Auburn. They are investigating a second hotel in Auburn to use as a home base. Stewart will send out statewide a Save—the—Date. Two classes so far have instructor fees that would require budget amendments:
 - Media training \$1,200 + hotel
 - OSHA training \$1,500 + hotel + travel
 - Asking for a \$3,000 overall increase to the Conservation Skills Workshop budget

Two other items that came up during the planning:

- We should consider donating to the farms we visit as they spend time and money making their operations available and cleaned up for us.
- Transport buses have come up again for classes. Expense vs parking for multiple cars at each site needs to be evaluated. Silvopasture class will be an hour away and may benefit a bus. Cuddeback stated they have used buses for events, and they do not like to leave the pavement. DiGiacomo stated a 36-person bus for 10 hours for \$1,200 for Envirothon. Stewart asked if there has been any feedback or complaints on people having to use District vehicle. Eskildsen stated no.
- A motion was made by Stoddard, seconded by Campbell to approve \$1,200 and a hotel room for the media training instructor and \$1,500

and a hotel room and travel for the OSHA training, totaling \$3,000 increase to the 2024 Conservation Skills Workshop budget per the 4-Hour Fund Application policy. Carried.

Bzduch left meeting at 2:24 pm Meeting suspended at 2:24 pm Reconvened at 2:40 pm

- e. **Administrative Conference** Lewis reported to Stewart that Saratoga County SWCD is beginning to work on the 2024 conference. Next week, they will reach out to those that have expressed interest in helping.
- f. Northeast Association of Conservation District Employees Parker submitted his report, appended to the minutes.
- g. **National Association of Conservation District** Parker submitted her report, appended to the minutes.
- h. **Frank Bratt Memorial Scholarship** Campbell shared her report, appended to the minutes. The next deadline is June 1^{st,} and she has only received one application. She is going to reach out to past applicants who did not receive funding to see if they are interested in reapplying. She reached out to one applicant whose funding was coming to expire but has not heard back. Stewart asked Campbell if she had received 2 Monroe County SWCD applications. She found one in her email and asked White to resubmit the other.
- Symposium went well. The feedback that she received was how squished people felt in group events as well as classes that had a large attendance and had to hold classes auditorium style. Attendees would like tables. Kemmeren is revamping the registration form for next year's event with Armstrong assisting her. Armstrong stated she received a Request for Proposals from three hotels and one hotel emailed her interested in submitting a Request for Proposals as they were not contacted this year. Cuddeback asked about the Buffalo Convention Center. Armstrong stated they did not have any dates in March available. Halloran suggested booking two years ahead. DiGiacomo stated Niagara Falls has a convention center too. Cuddeback suggested the registration form state no dogs are allowed. Stewart asked Armstrong to share the spreadsheet with the Board to look at and will vote in July for a hotel. Stewart thanked Armstrong for all the legwork she has done so far.
- j. New York State and NCF Envirothon Committee Kemmeren reported that forty-one teams competed at the State Envirothon with Mount Academy taking First Place from Ulster County. This year the Envirothon was held at a new location, SUNY Cortland, and the committee discussed holding the State Envirothon there again next year. They were short on volunteers but made it work. NCF Envirothon will be July 27th– August 3rd at Hobart and William Smith College in Geneva. They need lots of volunteers for this event. Volunteer requests have been sent out multiple times. Need 75-100 volunteers per day.

- Cuddeback asked how the budget is for the event. Stewart stated as of the NYACD meeting they were short \$70,000. Hurlbutt stated they are short \$50,000 as Farm Credit East donated \$20,000. Cuddeback asked if the committee hoped to raise the rest of the funds. Hurlbutt stated they hope so. Cuddeback suggested putting a blast out to the press in the Geneva area that they are looking for volunteers for the NCF Envirothon. Stewart added she will research Ontario County Lake Associations and contact them for volunteers.
- k. **Environmental Education Foundation** Burke reported a meeting was recently held. They are looking for 2 Board Members. The next meeting will be June 11th at 1:00 pm.
- 1. **Municipal Assistance Subcommittee** R. Cunningham reported they held a virtual meeting on May 13th with approximately forty people in attendance. A recording of the meeting is on SharePoint. The meeting was on NYSDEC permitting specifically for streams and wetlands. NYSDEC Region 5 and 7 permitting staff attended. Discussed regional differences in permits. Realized by region, they do things vastly differently. Conversations are continuing at Manager's Meetings. NYSDEC Region 5 permit staff stated a statewide general permit might not be a good idea due to all the differences we are facing now. She encouraged Districts to look into a regional general permit instead. Stewart thanked R. Cunningham for all his work on this problem and asked him to continue conversations with NYSDEC and work on this as it is a large problem for some Districts.
- m. Civil Service Committee Stewart reported that she contacted Deputy Commissioner for Municipal Services Joe Cavazos twice regarding updating the pool of exam questions, transitioning to training and experience tests, and the length of time it takes for exams to be held. She has yet to hear back and will contact him again. Halloran asked what all the various positions Districts have. Stewart replied she thinks you can create whatever position you want to. She just created a Senior Technician position and she had to write a job description for it. Stoddard stated she has a list of district employees and their titles if she would like to see it. Stewart stated she has spoken to her Civil Service point of contact in her county, and they stated if a civil service exam has not been offered in over 3 years that position would become a noncompetitive title forever. DiGiacomo stated he heard secondhand from a person who attended the Administrative Conference that if a test has not been offered in 3 years that position could be waived. Stewart replied yes but it must be done at a local level. Halloran stated that you are only doing the position, not the individual. They may not be protected. According to Stewart's notes from the Administrative Conference the position would be permanently exempt if the exam has been ordered but has not come up within 3 to 10 years your local civil service could make the title(position) noncompetitive forever. She was unsure if that would change the protective layer of the position or not. Hamilton and Clinton Counties have had good luck working with their local civil service departments concerning positions that have not been offered a test in years. O. Cunningham stated her position is

- noncompetitive and can be fired at any time but has state retirement and health benefits.
- n. New York State Invasive Species Advisory Committee Stewart reported that she serves as secretary for this committee and will attend the June 20 meeting. ISAC is a statutory body created in 2008 under Environmental Conservation Law to provide information, advice, and guidance to the Invasive Species Council. Up to twenty-five members from stakeholder organizations described or specified in the law constitute the Committee. Stewart represents Districts on the ISAC.
- Recruitment and Retention Committee Stewart reported that Natalie Shudt, Soil Conservationist of the NRCS Troy Field Office serves on the Envirothon committee is organizing a Career Day at the NCF Envirothon Competition on Sunday, July 28th, 2024, at Hobart and William Smith Colleges in Geneva, NY will be held from 8 am to 5 pm. This will give students the chance to see what opportunities lie ahead for jobs and schools and explore other companies involved in the environmental industry. Shudt inquire if CDEA is interested in setting up a booth. Tables and chairs will be provided, and she asks that we bring any materials we may need to display. The booth needs to be set up by 8 am since registration opens at 8 am. Stewart asked if anyone was interested in tag teaming and interacting with students at the Career Day at the NCF Envirothon Competition. Burke suggested contacting Alanna Robarge as the competition is in her county. Stewart mentioned that SWCC's Scott Fickbohm, Victor DiGiacomo, and Tyler Knapp developed a presentation about capacity building, recruiting, and retaining employees and how growth is assessed at the district level. Funding and staffing trends were assessed for Hamilton County. The overall trend that they see is increased funding in the recent past for the future but staffing not increasing at the same time. They discussed the challenges of recruiting and retaining employees and strategies to help with these issues.
- p. Leadership Institute placeholder until 2027

10. CDEA Activities

- a. Purchase Anker PowerConf Speakerphone Stewart reported that she recommends purchasing this speakerphone to improve audio during meetings, and to pick up voices from all directions in the meeting room. The connection is Blue Tooth Wireless and USB. Kelly Emerick highly recommended this speaker for CDEA meetings. Cuddeback stated one might not be enough especially in a large conference room. Stewart will research the range and if you can link the two together.
 - A motion was made by Halloran, seconded by Cuddeback to approve the purchase of an Anker PowerConf Speakerphone with a budget of \$300.00. Carried.

- b. NAACC transition R. Cunningham reported that he sits on this committee. They are looking for more Soil and Water personnel on the committee. It meets virtually on the 2nd Wednesday of the month. It is great to hop on and see what other agencies are doing. Spearheaded by NYSDEC and other partners like Cornell University. In Fall 2025, Scott Jackson, who runs NAACC through the University of Massachusetts, will be retiring. He is not sure if they are looking to transition part or all the work to another organization or partner. Cornell and DEC will most likely continue to offer training which is tied to lots of their program funding. The concern is who will take over the torch. The training will be tied to WQIP and the Bond Act. R. Cunningham heard from Lauren Prezorski at the most recent SWCC meeting that they will look for funding for smaller stream projects and NAACC-assessed culvert replacements. Will not know the details until next year concerning this.
- c. Soil and Water Outreach Funds Fickbohm reported Allen Martinez gave a presentation at the last Water Quality Symposium. He is from Cornell and working with Cargill who wants to get involved in agricultural conservation. The company would pay for the outcome of planting cover crops to reduce carbon. Martinez is interested in working in Conservation Districts to collaborate on an NRCS RCPP grant application. Stewart asked if any districts have or are looking to partner with any companies trying to get this funding. Fickbohm will look into it. Halloran was interested in talking to them as she hates to give money up. Stewart will invite Martinez to speak at the next board meeting. Cuddeback stated the payment is based on organic matter and that you do not see any increase in organic matter for 10 years. Fickbohm stated they are paying \$30 to \$40 per acre. Cuddeback mentioned on the website there is a gentleman from Cayuga County, and he will reach out to him. Brinkley asked where the interest was coming from. Fickbohm answered that private sector companies and other entities (Cargill, Organic Valley, DFA, etc.) are entering the agricultural conservation field as

- potential funders. Cuddeback asked if the Soil Health Institute at Cornell has been involved in this. Stewart thanked Fickbohm and R. Cunningham for bringing this forward. She will reach out to Martinez and invite him to a Zoom meeting.
- d. **4-hour Fund application review and approval (motion)** Stewart reported that she received one application. Discussion ensued.
 - A motion was made by Cuddeback seconded by Klemczak to approve Warren County SWCD's 4-Hour Fund Application for Hemlock Woolly Adelgid: Changing the Landscape of the Adirondack Forests in the amount of \$4,500.00. Stoddard abstained. Carried.
- e. **CDEA By-Laws update** Stewart reported that she received feedback from Amanda Barber and Kelly Emerick after the draft was printed and distributed for the annual meeting. A committee to review and incorporate feedback consists of Halloran, Stoddard, Stewart, and Armstrong.
- f. **CDEA News** Stewart reported the April CDEA News is hot off the press on the CDEA website: https://www.nyscdea.com/. She is taking news for the June edition. News is due Friday, June 7.
- g. **Management Development Certification Program** Halloran stated there was nothing to report.
- h. Ronnie Raindrop Stoddard reported that she received a nice email from Erica Schreiner that Ronnie Raindrop will turn 35 in 2025. Schreiner has old documents on Ronnie that she is willing to share with her. Stoddard will be working on an RFP for costumes for the even divisions. Stewart stated that Liz Wood made new costumes for the odd divisions but needed a new designer as she was hard to work with. If anyone knows of any costume designers, please let Stewart or Stoddard know.
- i. **Skeet, Trap, or 3-D Shoot Tournament** Burke reported she sent out an email seeking the popularity of Skeet, trap, or 3-D Tournament this fall. She received few responses. She is going to meet with Pompey Rod and Gun Club to see what they offer.
- j. **Other** Armstrong reminded everyone that the Kevin Lewis Memorial Golf Tournament deadline is next Friday. She also requested a new printer for the Water Quality Symposium. Stewart asked Armstrong to bring quotes to the next board meeting.
- 11. Correspondence Stewart reported she received a thank you email from Shino Tanikawa for receiving the Croney Award at the Water Quality Symposium. Another thank you email was received from Laura Sager for the 30-year Service Award plaque she received at the Water Quality Symposium. Stewart thanked Stoddard for an amazing job with the plaques. Stewart received an email from Corinna Aldrich past Division 6 Representative who gave a recap, comments, and suggestions for the Hospitality Suite at Water Quality Symposium. Chastity Miller emailed Stewart stating she was working on t-shirts for the NCF Envirothon and asked if CDEA was interested in donating. Stewart stated 4- Hour funds cannot be utilized for Envirothon, but money could be taken out of Office Supplies since the Zoom account was canceled. Stewart

stated Hamilton County has a Zoom account and her Board of Directors approved Stewart using the account for CDEA and other watershed coalition meetings in which she is involved.

- A motion was made by Campbell, seconded by Ferry to donate \$3,000 to NCF Envirothon. Carried.

<u>District Operations Sub-Committee</u>: No meeting scheduled at this time. District Operations Sub-Committee will be a topic on the agenda for the upcoming Regional Manager's Meetings. We are still looking for SWCD staff to participate on this committee. Please reach out to Victor DiGiacomo (<u>victor.digiacomo@agriculture.ny.gov</u>) and Ben Luskin (<u>ben.luskin@agriculture.ny.gov</u>) who will be working together to coordinate the District Operations Sub-Committee with questions or comments.

<u>State Programs Advisory Committee</u>: Meeting was held on April 29, 2024. The *DRAFT* CAFO Enhanced Nutrient & Methane Management Program was discussed to finalize RFP materials in preparation for a June 2024 release to SWCDs. Round 30 of the Agricultural Non-Point Source Pollution Abatement and Control Program was also on the agenda for the April meeting. The focus of this portion was to get feedback from Districts on the future direction of the program regarding how Waste Storage and Transfer Systems should be funded. The meeting recording is available on NYS SWCC SharePoint. Next meeting is scheduled for June 27, 2024.

Program Updates:

- Round 29 AGNPS Contracts are being reviewed and processed. 11 out of 32 contracts have been fully executed.
- Round 7 CRF Contracts are under development for Counsel review
- Round 8 CRF Q and A period has closed. The final Q and A document will be posted no later than June 10. Proposals are due **June 24, 2024.**

Other:

- NYS SWCC Strategic Plan was approved in April 2024 and is now available on the Department of AGM website
- Regional Manager's Meetings will take place between June 3 June 11.
- The EPF payment black out has ended. Claims for payment that were submitted during the black out were submitted to the Department of Budget for review and approval. These should be hitting District bank accounts in June.

- NYS SWCC Soil Health Policy BMP Certification Requirement: In response to correspondence that was received from a SWCD (received December 2023, presented to SWCC February 2024), the State Committee Voting Members have asked SWCC staff to review the BMP Certification Requirement that has been written into the guidance/policy to assess if any allowances can be made for SWCD staff who do not have CCA/appropriate NRCS Job Approval Authority but have years of experience and demonstrated knowledge, skills, abilities. To date, SWCC staff have completed a historical analysis of the BMP Certification requirement for a CCA to sign off on Soil Health practices. Understanding the timeline of the policy development and the reasoning behind the certification requirements will be important as we move forward with developing a recommendation to the voting members.
- NYS SWCC Equipment Purchasing Guidance in response to correspondence that was received from a SWCD (received May 2024, presented to SWCC May 2024), the SWCC has asked SWCC staff to draft Equipment Purchasing Guidance for SWCDs to utilize when developing grant applications that include equipment purchases. Concerns were discussed regarding liability to Districts with these projects, as well as, the proper/appropriate operation and maintenance for equipment purchased.





• Educational Programs: Our North Adirondack Regional Envirothon was held April 25th with along with Franklin, Essex and Clinton Counties. There were over 10 schools with approximately 140 people that participated in the event held at the VIC in Paul Smiths. There was a winner for each county and the overall winner of the region is going to the State Envirothon which is today (5/22) and tomorrow (5/23). One of our staff has gone to help with the State Envirothon. In June, the Conservation Field Days will be held

at Indian Creek Nature Center with staff and newly hired interns having an educational station there.

- Office: There were two intern positions that were advertised, and two people have been selected and offered the positions from the candidates that were interviewed, and they will be starting on June 3rd. Their main focus will be wetland easement monitoring but will also help out other staff with forestry and agricultural projects as they arise.
- Field Projects: We have 5 different contracts for AEM Tier 4 Implementation with projects including prescribed grazing, erosion control systems, and heavy use area protection system. We are hoping to get them going this summer. We also have an AgNPS waste storage grant that will be breaking ground this summer, and CRF cover crop projects and manure transfer projects. There is one CAFO grant that received an extension and we are hoping that this project will be completed. The AEM planner remains busy with actively planning for current and future plans and projects. The forester has completed the county forest management plan for all of the county owned forest parcels and is starting what is hoped to be the end of the Emerald Ash Borer County Right of Way project which involves driving county roads and marking all ash trees and hazard trees in the county right of way for removal by whichever company wins the bid. The forester is also working on private landowner forest management plans as time allows.

Steuben SWCD

Tioga SWCD staff are working on planning several education and outreach activities this summer, a series of 3 pasture walks that we are partnering with Tioga CCE and USC; Sundaes at the Farm event as well as participation at our county fair. In addition, we have several projects moving forward with implementation this summer, after we complete a number of riparian tree plantings this spring. We are moving forward with construction of several stream projects, and a flood mitigation project with our local CCE on a farm they purchased. As well getting our AEM implementation projects underway. We have 2 buffer stewards that received funding support through the USC and one engineering intern that we secured via Pro-Dairy. We continue to seek funding opportunities via state and federal resources, as well as engineering staff providing support to the USC member counties.
